We can help you with applying for, or accessing:

Here are some other things we've done for residents:

- Explained medical billing and insurance charges and set up payment plans if needed
- Found personal care aides and cleaning people

- Set up medical appointments

We work with other agencies in the county to help you get the help you need to stay in your home.

We will notify your family of changes in physical or mental conditions.
