



INTENSIVE OUTPATIENT DRUG & ALCOHOL PROGRAM

Customized treatment for individuals with a Substance Use Disorder

Family Service's Intensive Outpatient Program (IOP) provides individualized, strengths-based, trauma informed treatment to meet the varied needs of people striving toward recovery. We integrate traditional IOP components with co-occurring and trauma therapy while also considering basic needs to improve quality of life. Services are provided with a recovery-oriented team approach.

PROGRAM COMPONENTS

- Clients must attend a minimum of 3 groups and 1 individual session per week
- Clients may choose to attend up to 5 groups per week in order to address concerns that are indirectly or directly related to the Substance Use Disorder
- Program is designed to last 3 to 4 months depending on client's needs.

GROUP SCHEDULE

- Monday: 6:00 pm – 8:00 PM
- Tuesday & Thursday: 10:00 AM – 12:00 pm and 6:00 PM – 8:00 PM
- Friday: 10:00 AM – 12:00 PM

Please note: Family Service provides treatment and is not a level of care assessment site.



CRITERIA FOR ELIGIBILITY

- Adults ages 18-65
- Substance Use Disorder
- Meet IOP level of care as outlined by PCPC criteria
- Able to attend group sessions on weekdays during daytime or evening hours
- Can have secondary Mental Health diagnosis
- Must have Bucks Health Choices (Medicaid) or must be currently uninsured

Clients are admitted to this program through our Open Access walk-in hours:

- Monday & Thursday: 1:00 PM – 7:00 PM
- Tuesday & Wednesday: 9:00 AM – 3:00 PM
- Friday: 9:00 AM – 2:30 PM

Services are strictly confidential and adhere to Pennsylvania Drug and Alcohol and Mental Health licensing regulations and HIPAA regulations. Private information will be shared only upon written authorization.
