## **BUCKS COUNTY FAMILY CENTER**

The Bucks County Family Center offers family-friendly activities and services that strengthen family relationships and connect families with vital community resources. The Family Center hosts Family Nights throughout the year and an annual Family Fest each spring.

## **FAMILIES IN RECOVERY**

Families in Recovery offers support and education to families, parents and children who have been touched by addiction. Through group sessions, the program aims to help parents with substance use disorders learn healthy coping and parenting skills while balancing the needs of their recovery. Participants must be parents who are either experiencing active addiction or who are in recovery.

## **LINKS FAMILY REUNIFICATION**

LINKS Family Reunification assists and supports birth parents in addressing goals outlined by Bucks County Children & Youth Social Services Agency in working toward reunification with their children who are in foster care. Parents are also connected with other community resources that can support them in maintaining long-term stability and preventing re-placement of their children.

## **NURTURING PARENTING**

Nurturing Parenting provides in-home parent education and case management services designed to build nurturing skills as alternatives to negative parenting attitudes and practices. Trained Facilitators use evidence-based assessment tools and curriculum materials to identify “high risk” parenting practices and beliefs that could potentially put a child at risk. Facilitators customize the curriculum to build on parents’ strengths and address weaknesses in order to reduce or eliminate the need for future intervention.

## **PARENTING TOGETHER**

Parenting Together offers co-parenting classes for parents or caregivers experiencing problems with communication. Classes are designed to help parents work together effectively to promote the best interests of their children following separation, divorce or other conflicts. Classes do not need to be attended as a couple. Parents, grandparents, foster parents and any other individuals who co-parent with another to provide direct care for a child can participate.

*Group and private classes are available. There is a fee for this service, and all participants will receive a certificate of attendance.*

## **PARENTS AS TEACHERS**

Parents as Teachers is an evidence-based Early Childhood service that assists families with parenting, promotes child health and development, prevents child abuse and prepares children for kindergarten. Participating families and their preschool-aged children receive personal visits from a Certified Parent Educator, health and development screenings and a network of resources.

**With the exception of Parenting Together, services are free of charge and open to families throughout Bucks County. Families may enroll in multiple programs based on needs and interests.**
