# **EVERY FAMILY DESERVES A HOME.**

The Bucks County Emergency Homeless Shelter, a program of Family Service, is a temporary residence for individuals and families who have lost safe and stable housing. The shelter operates 24 hours a day, 365 days a year and accommodates approximately 75 people at any given time. Typically, about a third of the residents are children. The shelter has a large dorm area for women and children, a moderate-sized dorm area for men, and three private family units.

On-site services for shelter residents include case management, job search and preparation, budget planning, outpatient counseling, transportation, and nursing services including health evaluations, referrals, and assistance with food and nutrition counseling.

Over the past year, we have installed new windows, replaced flooring in the dining area, added an HVAC unit, upgraded the security system, replaced outdoor lighting and beautified the outside grounds at the shelter. In addition, we have enhanced dietary services by providing nutritionally balanced meals through an outside food service vendor.

Contributions from generous donors and the incredible effort put forth by hundreds of hard-working volunteers each year are the driving force behind the shelter's sustainability.
